### Qualifications:

#### Job Specific:

- 1. Pricing is based on a single mobilization.
- 2. This estimate assumes standard labor pricing.
- 3. This proposal assumes a crewsize of 2 working a shift of 10 hours a night.

#### General:

- Refurbishment of the air handler will be executed on a schedule as agreed to by the client. At a minimum, the air handler will be completely shut down for eight (8) hours on multiple, consecutive days or nights, and the shutdown period may be longer than eight (8) hours.
- 5. Payment and performance bond is excluded.
- 6. Roofing and/or roof penetrations of any kind are excluded.
- 7. Concrete of any kind, including pads is excluded.
- 8. Work associated with any unforeseen conditions is excluded.
- 9. Temporary facilities, utilities, air conditioning or ventilation is excluded.
- 10. Wiring/interlock of smoke, fire/smoke and other life safety devices is excluded.
- 11. Data cable, drops and IP addresses are excluded.
- 12. Lightning protection is excluded.
- 13. Removal and replacement of hard lid ceilings, walls and chases is excluded.
- 14. Removal/relocation of existing utilities for installation of new systems is excluded.
- 15. Wet taps, line stops, and/or pipe freezes are excluded.
- 16. It is assumed that all existing systems are in fully functional good working order. Service, repair, and/or replacement of existing systems not specifically listed above is excluded.
- 17. Owner is responsible for closing and opening any existing isolation valves.
- 18. It is assumed that there are existing isolation valves in fully functional good working order for connection of new piping systems.
- 19. ICRA containment of any kind is excluded.
- 20. Code Repairs and/or upgrades of any kind are excluded.
- 21. Pricing is valid for 30 days.
- 22. Due to the volatility of materials and commodities, any escalation greater than 3% from time of submission, will require additional reimbursement. WTI will provide a change order request detailing the pricing escalation.
- 23. Local/State industry governing body review is excluded.
- 24. Pricing includes standard warranties for all equipment from startup.
- 25. All work associated with hazardous materials including, but not limited to asbestos, lead, petrochemicals, arsenic, or any other hazardous material sampling, abatement, handling, and/or remediation is excluded unless specifically referenced.
- 26. This proposal and budget is based on mutually agreeable contract, cash, schedule, projections and billing terms. These terms shall be solidified prior to the award of the project.

#### PURE-Steam:

- 27. Due to potential degradation conditions of some evaporator coils as a result of years of harsh chemical application and/or environmental condition, certain coils may have limited results.
- 28. The following steps should be followed by the owner so as to increase our success in coil cleaning. Prior to steam cleaning the owner should complete the following:
  - a. Close isolation valves of cooling coil;
  - b. Cooling coil should be void of all water; and
  - c. Strainer should be removed and cleaned.


