Dr. Dandoy shared that the quarter 3 Strategic Planning update link is available on the board agenda, and he encouraged the Board to view it. He also shared that the Turner Foundation voted unanimously to shift concession/snack bar operations at sporting events to Opaa!. Opaa! will still allow groups to fundraise by staffing large events like Friday night football. Dr. Dandoy toured the new literacy room at TRC and encourages Board members to stop in. It is a great space to extend the library for our youngest community members. He also shared that State Assessment administration will wrap up this week.

**Joy Beery-** Ms. Beery inquired about the district theme for the next school year. The theme is "Raise the Bar", and it focuses on high expectations for our learners. Ms. Beery also shared that the JSOC presentation makes her proud to be a part of the Turner School District.

**Bryan Fishbaugh-** Mr. Fishbaugh shared that he was sorry to hear about the loss of Dave Dugan and sent condolences to his family, friends, and staff mourning his loss. He also shared that he really enjoyed the NASB conference that the Board attended, and he very much enjoyed the Focus on Learning presentation by JSOC this evening. It was wonderful how the students mentioned various staff members that have helped them.

**Steve Russell-** Mr. Russell shared that it was great to hear the parent input about JSOC during this evening's Focus on Learning presentation. Parents have expressed their appreciation to him for the program and the principal, Dr. Duewel, has done an excellent job. He shared that at the NSBA conference it was valuable to hear from other school boards and administrators from across the nation, however the conference presenters have not been as good in the last couple years. He suggested possibly trying the conference of NASB's competitor next year. Mr. Russell would also like to closer examine how the mills levied for Turner Recreation are being spent and if the community is getting what they are paying for. He thinks this is an area where the Board could possibly roll back some mills and lower the tax burden on the community.

**Theresa Rangel-** Ms. Rangel shared that she really liked the JSOC presentation and wished more students would take advantage of the program. She also appreciated attending the NSBA national conference. She always finds it be to eye opening talking with other districts throughout the county about their operations.
