### **Turner Recreation 2022-2023 Budget Discussion**

At the time this item was presented for discussion (6:25pm) no one from the Turner Recreation Commission was present to present the budget. After phone calls were made, Robbie Spencer advised he was coming to the meeting. The item was tabled and pushed back until later in the meeting. Robbie Spencer arrived at 7:10pm for the meeting and apologized for being late. Mr. Spencer did not provide either printed or electronic copies of the budget for the board to review. He said it was the same budget as the one he presented during the joint Turner Recreation/Turner USD meeting with just a few changes and there was no change in the mills being levied for revenue. There was discussion regarding the programs offered, website, marketing and the value of what the community received for the mills levied.

The Turner USD board encouraged bringing senior adult programs and activities back and look at reducing the mill rate that Turner Recreations levies. Dr. Dandoy informed Mr. Spencer that the YMCA is willing to do before school care under Turner Recreation's licenses and Mr. Spencer said that would be fine.
