# **Superintendents Report**

Dr. Dandoy shared that we had three students place in state wrestling, including our first female wrestler. He also shared that the District is posting a number of jobs that will be funded by ESSR funds such as intervention positions. Currently the District is focused on returning high school students to a full schedule starting March 22nd and working with health department to get assurances that we will be able to proceed with these plans. If we do not receive assurances from the health department, it may be necessary to hold a Special Board Meeting to discuss options. Dr. Dandoy also discussed how changing the Local Option Budget from 30% to 31% would affect the community and shared that we need to inform KSDE of our intent to increase the LOB to the state.
