SCOPE OF WORK

KC IRRIGATION SPECIALISTS SHALL PROVIDE ALL NECESSARY LABOR, MATERIALS AND EQUIPMENT TO PERFORM ALL WORK ON THE PROPOSED PROJECT IN ACCORDANCE WITH THE CONTRACT, THE SPECIFICATIONS AND IF APPLICABLE, THE ACCOMPANYING DRAWING. ALL WORK SHALL BE COMPLETED IN A WORKMAN-LIKE MANNER, IN A TIMELY FASHION AND IN COMPLIANCE WITH ALL BUILDING CODES AND APPLICABLE LAWS.

PERMITS

KC IRRIGATION SPECIALISTS WILL APPLY AND OBTAIN ANY AND ALL NECESSARY PERMITS TO COMPLETE THE CONTRACTED WORK.

LOCATES AND UNDERGROUND UTILITIES

KC IRRIGATION SPECIALISTS WILL CONTACT AND SCHEDULE THE MARKINGS OF ALL PUBLIC UTILITIES THAT WILL BE IN THE WORKING AREA. KC IRRIGATION IS NOT RESPONSIBLE FOR THE MARKING OR REPAIR OF ANY UNMARKED PRIVATE UTILITIES. IT IS THE RESPONSIBILITY OF THE OWNER TO HAVE PRIVATE UTILITIES AND STRUCTURES MARKED PRIOR TO THE START OF WORK OR THE OWNER WILL ASSUME FINANCIAL RESPONSIBILITY OF THE REPAIRS.

PROPERTY LINES

THE OWNER OF THE PROPERTY WILL MAKE AWARE TO KC IRRIGATION SPECIALISTS THE CORNERS OF THE PROPERTY AND ANY AREAS OF QUESTION AND SHALL ASSUME RESPONSIBILITY OF ITS ACCURACY. SHOULD THE SCOPE OF WORK EXTEND OUTSIDE OF THE PROPERTY LINES, APPROVAL BY THE OWNER WILL BE ASSUMED AS LEGAL PERMISSION FROM ALL PARTIES INVOLVED.

SOIL CONDITIONS

KC IRRIGATION SPECIALISTS RESERVES THE RIGHT TO ADD UP TO 20% OF LABOR COSTS DUE TO EXCESSIVE ROCKS, DEBRIS AND UTILITIES BELOW THE SURFACE OF GRADE. KC IRRIGATION WILL DO THEIR BEST TO RETAIN THE INTEGRITY OF THE WORKSITE BUT IS NOT RESPONSIBLE FOR THE REPAIR OF GRADE OR TURF CAUSED BY NORMAL INSTALLATION PRACTICES.

KC IRRIGATION SPECIALISTS SHALL MAINTAIN ALL GENERAL LIABILITY AND WORKERS COMPENSATION AND WILL PROVIDE PROOF OF INSURANCE UPON REQUEST. ANY BONDING OR ADDITIONAL INSURANCE COVERAGE COSTS WILL BE APPLIED TO THE FOLLOWING OR FINAL INVOICE.

CHANGES TO SCOPE OF WORK

OWNER MAY MAKE CHANGES TO THE SCOPE OF WORK DURING CONSTRUCTION OF THE PROJECT. HOWEVER, ANY CHANGES OR MODIFICATIONS MAY RESULT IN A CHANGE IN PROPOSAL AMOUNT AND, IF DEEMED NECESSARY, A CHANGE ORDER WILL BE PROVIDED TO THE OWNER TO BE SIGNED BY BOTH PARTIES AND CHANGES WILL BE APPLIED TO THE FOLLOWING OR FINAL INVOICE.

CONSENT OF OWNER

CONSENT IS HEREBY GIVEN FOR FILING OF MECHANICS LIEN BY ANY PERSON WHO SUPPLIES MATERIALS OR SERVICES FOR THE WORK DESCRIBED IN THIS CONTRACT ON THE PROPERTY ON WHICH IT IS LOCATED IF THEY ARE NOT PAID. HOWEVER, TO AVOID THIS RESULT YOU MAY REQUEST A "LIEN WAVER" FROM ALL PERSONS PROVIDING MATERIALS OR SERVICES.

TERMS, LATE PAYMENT AND DEFAULT

KC IRRIGATION SPECIALISTS WILL PROVIDE TERMS OF NET 30 FOR THIS PROJECT. A FAILURE TO MAKE PAYMENT FOR A PERIOD IN EXCESS OF TEN DAYS FROM THE DUE DATE SHALL BE DEEMED A MATERIAL BREACH OF THIS CONTRACT. IF PAYMENT IS NOT MADE WHEN DUE, KC IRRIGATION SPECIALISTS MAY SUSPEND WORK ON THE JOB UNTIL PAYMENT DUE HAS BEEN MADE. OWNER AGREES TO PAY A LATE FEE OF 1.5% OF ALL PAYMENTS THAT ARE MORE THAN 10 DAYS DELINQUENT PLUS INTEREST RATE OF 1.5% PER MONTH. IN ADDITION, OWNER SHALL PAY ALL COSTS OF COLLECTIONS INCLUDING COURT COSTS AND REASONABLE ATTORNEY FEES IN THE EVENT PAYMENT IS NOT MADE IN ACCORDANCE WITH THE TERMS OF THIS CONTRACT.

WARRANTY

KC IRRIGATION SPECIALISTS WARRANTS TO ITS CUSTOMERS FOR A PERIOD OF (1) ONE YEAR AGAINST ALL MANUFACTURING DEFECTS IN MATERIAL AND WORKMANSHIP OF PRODUCTS. THIS WARRANTY IS LIMITED SOLELY TO THE OWNER OF THE PROPERTY AT THE TIME OF INSTALLATION. WARRANTY BEGINS ON THE FINAL DAY OF INSTALLATION. KC IRRIGATION SPECIALISTS IS NOT RESPONSIBLE FOR ONGOING TRAINING AND MONITORING OF THE PRODUCT. THESE SERVICES CAN BE PROVIDED AT AN ADDITIONAL COST. IN THE EVENT OF A WARRANTY ISSUE, IT IS THE RESPONSIBILITY OF THE OWNER TO NOTIFY KC IRRIGATION SPECIALISTS IN A TIMELY MANNER.


