### **TRC Revenues/Mills & Expenditures**

Mr. Spencer provided an update on the Turner Recreation budget. They are looking to start a music program that is similar to the Learn to Bike and Learn to Swim program. There have been issues with custodial staffing and they may change to a custodial service, for which they would do an RFP. They have also been awarded a matching grant for the front of the TRC building and sitting area, but they will not start work on that project until all of the funds are available.

Ms. Rangel shared a presentation she created to discuss program expenditures, lack of new programming, staffing expenditures, and a recommendation they stay revenue neutral.

TRC board members expressed frustration about the talking points and questions that were raised during the meeting.

There was also a discussion regarding the financial responsibility of the TRC Board to the taxpayers in the community.

A representative from Turner Recreation is supposed to attend Turner USD Board Meetings monthly to provide updates on TRC, however that has not occurred the previous two months. There was discussion by TRC board members that they are not comfortable attending these meeting to provide the updates as they feel they are being treated unprofessionally.

There was also discussion around how they can foster a better relationship between the Turner Recreation and Turner USD board.
